### **HMEP Grant update (Matt Doughty)**

- The amount allocated to the Chicago LEPC is \$125,000
  - This is a restrictive grant
  - Recommendation to use CERP and data from commodity flow study
  - Have until March 1 to submit request
  - Recommended exercise area would include 16<sup>th</sup> Wood and Ashland or South Loop which is a heavily populated area
  - o RFP to vender
  - Training and/or exercise
  - Lead into full scale exercise next summer
- Bill Schatz inquired about dollar amount spent on exercise. Matt responded entire amount
- Terry Sheahan commented he preferred the South Loop area
- Bethany Hand noted she would reach out to the State regarding the guidelines
- Glen Lyman recommended using some of the money for live Ammonia training for CFD personnel.
  - Determination as soon as possible decision can be made.
- Bill Schatz (CFD Ret) made note that Cook County LEPC (CCLEPC) does not get the HMEP Grant
- Barbi Lee (EPA) noted the CCLEPC) just had their first in-person meeting since the pandemic started.
- John Plante (Metra) noted that Metra is required to conduct a emergency response scenario every two years and might be able to coordinate with the LEPC exercise.
- Chair Glen Lyman read email from Paul Ruesch recommending possible scenarios for exercise.
- Matt Doughty informed the group that on Tuesday December 21, 2021, there is a FIMS/CPS subcommittee meeting. Chair Glen Lyman will email CFD Chief Satriano and CFD Chief Sullivan of the meeting.

## **Tier Two Update (Terry Sheahan)**
