### **FIMMS Meeting**

- Bill Schatz inquired about the FIMMS meeting attended by Matt Doughtie since the December meeting.
- Matt Doughtie provided the following update
- Responsibility has been transferred to new Chicago Police Department (CPD) personnel
- The CPS platform is still being used
- Bethany Hand inquired about the priority status related to the project
- Matt responded that the platform lives within CPD and it appears they are starting from scratch with new CPD personnel.

## **HMEP Grant update (Matt Doughty/Bethany Hand)**

- The Task Order Request has been distributed and sent out to venders listed on the City of Chicago Qualified Venders Distribution List
- Venders are required to have bit in by March 16, 2022
- Tabletop exercise requires completion by June 1, 2022
- Exercise component requires completion by August 5, 2022
- OEMC is looking to put together an Evaluation Committee compose of no more than five (5) individuals from multiple agencies.

- John Plante recommended since there will be a transportation component to the tabletop and exercise, a member from transportation on the Evaluation Committee.
   Tom Kennedy from CTA was recommended.
- John Plante will represent the Chicago-LEPC
- Chair Glen Lyman will reach out to Chief Sullivan (CFD) regarding representing the Fire Department as part of the Evaluation Committee
- Matt advised the group that the group is looking to focus on the sites previously mention at the LEPC meeting (16<sup>th</sup> & Wood and Ashland and/or South Loop area)
- The project shall use the entire amount of the funding that is available.
- Chair Glen Lyman informed the group of his conversation with Chief Sullivan (CFD)
  regarding having shovel ready CFD training quotes ready for the next fiscal round of
  funding. Therefore pushing the portion discussed in the 2022 funding to the 2023 fiscal
  funding cycle.
- Bethany informed the group that the 2023 grant cycle requests are due in by end of April 2022.
- Glen Lyman will reach out to Chief Sullivan and inform him of the deadline. Training grant request must also include a transportation element in the justification for approval.
- Bill Schatz informed the group that he spoke with Cook County LEPC and their group does not apply for the HMEP grant.
- Glen Lyman after review of the draft "Task Order Proposal Request Memorandum" that wording is added to include the Chicago-LEPC as a retainer of all products (reports, drafts, etc.) of this deliverable. Matt Doughtie agreed to the request.

- Alvin Childress advised the group that there is still some difficulty with using the portal by those required to use the portal.
- Still receiving hard copies of the TERR II reports.
