Introductions & Affiliation's:

Meeting was called to order at 10:05 am by Chairperson Glen Lyman. Introductions and Affiliations were made.

Motion made by Chair Glen Lyman second by Bill Schatz to approve the **Minutes for March 8, 2022**: were reviewed and approved. The minutes/agendas shall be posted on the webpage https://chicagolepc.org/

Update on Greater Chicago Sub-Area Contingency Plan (Paul Ruesch EPA)

- The area has been divided up into 27 spill response zones with an individual assigned as on-site control for each designated area
- Plan is designed as a guide to a worst-case scenario discharge
- The refinery located in Jolliet Illinois has a large quantity of oil on site with the potential of a large discharge ending up in the Illinois River.
- The Greater Sub-Area Contingency Plan provides response strategies
- Paul requested assistance with reviewing the plan
 - Matt Doughty (OEMC) will be POC from OEMC for review
- The plan is legally required by the EPA
- Once approved the Plan shall be shared with agencies responsible for responding
- Paul will send out invite for participants to review the plan and place the plan draft on the EPA website
- Bill Schatz inquired if such a plan was required in other states. Paul responded: the plans are required every five (5) years and clarifies jurisdictional lines.

- Paul Ruesch provided a briefing on the Metra cash in Clarendon Hills on May 12, 2022 in which resulted in diesel and oil entering a creek
 - Supporting agencies were able to create an underflow dam to capture the majority of the 100 gallons (reportable quantity).
- Paul also provided a short briefing on the Springbrook Illinois boat explosion on May 9, 2022, where fourteen (14) individuals were injured, one (1) critically.
 - Hard boom was used for water containment
 - Commented that Water Management may have hard boom available at the Jardine Water Purification Plant

LEPC exercise Update (Matt Doughty OEMC & Jeremy Kaufman Tetra Tech)

Tabletop Purpose

Exercise play is limited to the review of emergency plans, as well as policies and procedures related to multi-organizational response to a large-scale transportation incident involving hazardous materials.

Scenario

A train derailment results in a significant release of a hazardous material vapor to the surrounding neighborhood including the transecting railway corridors. The incident poses a hazard to the local community and has the capacity to create significant disruption to critical transportation lines.

- Critical Transportation
- Environmental Response/Health and Safety
- Operational Communications
- Operational Coordination
- Situational Assessment
